1.0 Preamble:

TIFR Hyderabad is a premier research institute located in Gopanpally Hyderabad, India. To reap the benefits of technology, it is proposed to build E-class room. This inquiry is for supply, installation and testing of video conference equipment and accessories. The proposed solution should be fully compliant for dual stack, IPv4 and IPv6 communication from day one.

2.0 Scope of work:

The scope of work in brief includes, supply, installation, testing, commissioning, integration and training on video conference equipment to build state of the art E-class room. It is mandatory for the bidder to visit the site to understand the site requirement before bidding for the project. 3.0 Terms and conditions of the inquiry:

a) Both Technical Bid and Commercial Bid should be submitted before the due date. Two bid system: The bidder has to sign and seal all the pages of the inquiry document and Bill of Material (BOM) before submitting the bid.

Both Technical Bid (Part A) and Financial Bid (Part B) to be submitted within the due date and time in separate envelopes and marked on top as Part A and Part B. These two sealed envelopes should be further put in one Master Envelope super scribed with the Tender No., Due Date in Bold Letters.

PART "A" (Technical Bid) consisting of Technical Bid with Commercial Terms and PART "B" (Financial Bid) consisting of only Price shall be submitted in separate sealed envelopes duly superscribed with the tender enquiry number, and the due date in bold letters, addressed to the Administrative Officer, Tata Institute of Fundamental Research, Plot No.36/P, Gopanpally Village, Serilingampally Mandal, Ranga Reddy District. - c) The validity of the price bids should be at **least 90 days** from the date of opening of technical bid. If required, should extend the price validity.
- d) The supplier shall bear all costs associated with the preparation and submission of the bids. TIFR will not be responsible or liable for part or all of those costs under any circumstances.
- e) Supplier should have **experience of five (5) years** in system integration and should have a team of qualified and experienced engineers to handle the project. Details of local technical manpower should be submitted with the technical bid. Supplier should have full-fledged office and support personnel stationed in Hyderabad. Relevant documents should be submitted to support this clause.
- g) To qualify to bid for this inquiry, supplier should have given Video Conferencing (VC) / E-class room/ Auditorium VC solutions to **three customers in India**. Purchase order copies and contact details of the technical person(s) (customer end) associated with the order should be part of the submission. TIFR-H will have right to check on quality of technical services and support with your customers who have given orders for supply of VC equipment. The projects must be pertaining to installation and commissioning of VC equipment in an enterprise environment. Copies of purchase order and commissioning report (customer acceptance report) have to be submitted.
- h) Supplier should do Proof of Concept (PoC) at TIFR-H with the proposing solution and take the sign of technical personnel. This is compulsory to all the bidders. - i) TIFR reserves the right to accept or reject any or all bids.
- k) The Bidder shall also be responsible for proposed solution, successful project implementation and post installation support.
- 1) Obsolete or near end of sale products will not be accepted.
- m) The supplier should not be currently blacklisted by any corporate/central/state government department / public sector unit. Bidder should provide self declaration of the same.
- n) The price quoted should be firm and final. Under no condition price escalation is allowed. Only one solution should be proposed with price bid. Quoting multiple solutions with multiple price bid will lead to rejection of the bid.
- o) **Performance Bank Guarantee**: Performance Bank Guarantee for 10% of the value of supply should be provided and it should be valid for 60 days beyond the date of completion of all contractual obligations of the supplier including warranty period. Performance Bank Guarantee should be from Nationalised Bank. In case Performance Bank Guarantee is not provided, 90% payment only would be released and balance after 60 days beyond the date of completion of all contractual obligations of the supplier including warranty period. Vendor should clearly mention their acceptance to this effect in their quote.
- p) TIFR is exempted from paying of Custom Duty under the notification No.51/96 dated 23.07.1996, Excise Duty under the notification No.10/97 dated 01.03.1997, for all procurements/supply meant exclusively for Educational, scientific and research purpose. Whenever



the exemption certificate not honored by the authorities, the applicable duty will have to be paid. Hence Excise & Custom duties, if any, should be shown separately.

- b) The proposal shall be valid for acceptance by the purchaser for 90 (Ninety) days from the date of technical bid opening and shall be extended by such period as may be needed for finalization of order.

- c) Liquidated Damages: The complete project implementation shall be completed within 2 (two) weeks from the date of delivery period as mentioned in quotation, failing which liquidated damages at a rate of 1% of P.O. value per week of delay of commissioning beyond the stipulated period with an upper ceiling of 10% of the purchase order amount for all delays which do not merit any extension of time, will be levied. The countdown for commissioning will start from the date of delivery period. The liquidated damages shall be recovered from the payment due to supplier from this or any other contract with the purchaser.
- d) On-site hands-on training to TIFR-H staff for all the equipment supplied to be conducted by the supplier / OEM.
- e) Deviation from the specifications: The offer shall be made conforming to the specifications of this inquiry. Any deviation from the specifications shall be clearly brought out in a separate sheet. The bidder shall not make any addition / alteration in the text of the specifications. 5.0 Support and technical requirements:

a) The proposed solution, hardware and software, shall be covered under **comprehensive onsite** warranty for five years (5) from the date of final signoff by TIFR-H. Release of new version of operating system, application, firmware, bug fix patches etc. for the supplied equipment should be patched / upgraded for stability and security of the system by supplier / OEM team. Supplier / OEM support team should advise and support this activity during the warranty period. During



warranty period supplier team should upgrade and update the equipment to higher versions of firmware and operating system as and when released by the manufacturer.

- b) All supplies, hardware and software, shall have comprehensive five years onsite support with OEM service window 8x6 (hrs x days), with NBD advance spare parts replacement.
- c) Necessary mounting brackets, railings, power chord, cables etc. should be part of the proposal.
