



1	Is there any fees to pay for it?	No, there is no fees for the enrollment process.
2	Is there any online format to submit the paper?	No, physical registration form as available in Section VII of the tender document, to be submitted, along with all supporting documents.
3	What is the deadline for submission?	The submission must be made on or before 08.06.2026 by 1:00 PM
4	Previous we submitted registration certificates of ESIC/PF/GST etc. to TIFR Hyderabad, do we need to submit it again?	Yes, all documents as per this tender requirement are to be submitted freshly for the empanelment.
5	Is GST & TDS returns to be submitted?	No. only registration certificates of GST/PAN is sufficient and annual turnover for the last three financial years are also to be submitted.
6	Do we have to submit all pages of the application and experience certificates?	Yes, registration form for the relevant category to be filled in, along with the all valid documents to be submitted as per the eligibility criteria outlined in the tender document at Section VI.
